- (1)The visa fee is collected by the Visa Center on behalf of the Chinese Embassy. The consular officer will determine whether to issue a visa, as well as its validity period, duration of stay and number of entries, based on the applicant's individual circustances. The final decision shall be subject to the approval of the embassy.

- (2)The application service fee is charged by the Visa Center. Regardless of the visa approval result, the service fee is non-refundable.

 (3)The total amount payable by the applicant= Visa Fee + Application Service fee (non-postal application)

 (4)The fee for applicants from third Countries may differ from those stated in the schedule. Please refer to the actual amount required for payment.

 (5)Postal Application=Visa Fee (collected for the Embassy)+Visa Service Fee (charged by the Visa Center)+Postal Service Fee (charged by the Visa Center)+Postal Fee (charge office, payable separately to the post office; the price is not included in this schedule; please inquire with the Center separately).

Postal service: After receiving the "Visa Application Confirmation Email" and "Visa Application Confirmation Certificate," the applicant sends the passport and other application materials to the Visa Center. The Center processes the application upon confirmation of payment receipt. And on the date of collection, after receiving the visa and passport returned from the Embassy, the Center will individually arrange for the applicant's passport and visa to be handed over to the post office. The post office then provides return mail service based on the applicant's return address and charges the corresponding fee, eliminating the need for the applicant to pick up the documents in person at the Center.

When the center returns your passport and visa by mail, each return envelope will contain no more than 5 passports (inclusive). If the number of passports exceeds 5, an additional return envelope will be used, and so on. According to the post office's fee standards, a postage fee of 5000₩ will be charged for each return envelope

Typically, applicants can receive their passports within 2-3 business days from the date of mailing (delays may occur under special circumstances). Mailing applications do not offer Express or Urgent service. Processing for mailing applications requires 7 business days (excluding round-trip mailing time; some applications may require longer review periods, for which the Center will

provide separate notification. For detailed procedures, please refer to the notice on the Center's website).

(6) For non-mailing applications requiring Express or Urgent processing, additional Embassy visa expedited fees and Visa Center expedited service fees must be paid.
